In September, this ecosystem was further strengthened with the acquisition of Altinco – a manufacturer of zero-residue biosolutions for crop protection – and a strategic alliance with Banco Santander to provide farmers with financing to transform Spanish farms into high-value crops such as olives and almonds, in both intensive and super-intensive models.
